\*Federal regulations require that local historic district commissions in communities participating in the Certified Local Government Program (CLG) be notified 60 days in advance if a property in their community is being presented to the Arkansas State Review Board for consideration of listing on the National Register of Historic Places. The CLG communities in Arkansas are: Little Rock, North Little Rock, Helena-West Helena, Hot Springs, Eureka Springs, Fort Smith, Van Buren, Osceola, El Dorado, Rogers, Conway, Texarkana, Pine Bluff, Morrilton, Blytheville, Fayetteville, Batesville, Russellville, Benton, Fairfield Bay, and Dumas.
